Workshop on curbing the menace of Ragging in Higher educational institutes and implementation of National Ragging prevention project which is organized by the Anti-Ragging committee, Abhayapuri College. At the beginning of the workshop Principal Dr. Sadananda Nath give a brief presentation of the initiative taken by our institution, some of its action taken are mentioned below. Abhayapuri College on its part has a very strict mechanism to deal with ragging within and even outside its academic and hostel campus. The anti-ragging committee of the college has been constituted in accordance with the UGC and government guidelines. The committee also follows all the orders of the Honourable Supreme Court regarding anti-ragging. The anti-ragging committee of the college constituted as per the UGC guideline in which a representative from the local civil (S.D.O. North-Salmara subdivision), another from the police administration, and a nominated member from Abhayapuri press club (local media) included a member. Special measures are taken to prevent ragging at the time before, during, and after the admission. An antiragging squad constitutes comprising teachers/employees and students to prevent ragging in the college/hostel campus. The anti-ragging squad also take the initiative to prevent ragging in private hostel/lodge. Every year awareness programs among the students about UGC rules, regulations & instructions regarding ragging and its consequences, etc. are arranged during the time of new admission and after admission. A number of initiatives are taken to make the college and its hostel a ragging-free zone. It is worth mentioning that there is no record or report of ragging in the college up till now. This is the only thing possible because of the robust policy of the committee and strict vigil taken by the ragging prevention squad during all working days of the college.

1. The anti-ragging committee of the college has been constituted in accordance with the UGC and government guidelines and the committee also follows all the orders of the Honourable Supreme Court regarding anti-ragging.

2. CCTV cameras were installed in most of the classrooms, common and vulnerable areas

of the college, and are constantly monitored by the principal's office.

3. Banners and posters of anti-ragging are arranged to show in most of the prominent places of the college and hostel campus.

4. An anti-ragging squad constitutes comprising teachers/employees and students to prevent ragging in the college/hostel campus. The anti-ragging squad also take the initiative to prevent ragging in private hostel/lodge.

5. Every year awareness programs among the students about UGC rules, regulations & instructions regarding ragging and its consequences, etc. are arranged during the time

of new admission and after admission.

6. In our admission prospectus and college website contain the UGC regulations and link of the same is included.

7. National anti-ragging helpline no is shared with all employees and students by the respective students/teachers/mentees' WhatsApp groups.

8. Our college prominently displays posters depicting the provisions of panel law applicable to incidents of ragging.

9. College anti-ragging helpline no shared with all students and prominently displayed the mobile phone no of the warden in the hostel. (Both Boys & Girls)

- 10. Every faculty member of the college is allotted a minimum of 60 students as mentees. Each faculty member conducts regular counseling and discussions with their mentees to keep the students in constant touch with faculties and the college authorities.
- 11. All college students are asked to submit an anti-ragging affidavit (ONLINE this year) per year.
- 12. The wardens of both the boy's and girls' hostels constantly monitor the hostels and organize counseling programs on a regular basis.
- 13. There is a practice of surprise visits of faculty members/anti-ragging squad to the hostels.
- 14. Banners indicating the punishable laws against ragging in any educational institute have been placed in different places within the college campus, to make the students aware of the laws against ragging.

At the end of the workshop, the resolutions are adopted unanimously as follows

Resolutions 1

An instruction be prepared to circulate among the students for an online Affidavit of all students and their parents containing all necessary documents of the institution. All faculty members are requested to circulate the instruction among their students/mentee groups.
