MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

ABHAYAPURI COLLEGE

AND

RESOURCE CENTRE OF UN - NORTH EAST REGION (RCUN-NER)

23RD APRIL, 2021

VENUE: ABHAYAPURI COLLEGE

Resource Centre of UN - North East Region (RCUN-NER) and Abhayapuri College (AC) have agreed to the following on 23rd day of April, 2021

1. Purpose: It is the MOU for the cooperating parties to give on the development of the College in the field of Education, Science, Culture, and Environment and sustainable development.

2. Areas of Cooperation:

- a) Abhayapuri College has agreed to assist RCUN-NER for promoting UN/UNSECO programmes in the college Jointly.
- b) Abhayapuri College will execute the activities / Programmes of RCUN-NER while RCUN-NER will support the Abhayapuri College to execute it.
- c) Abhayapuri College may provide Conference Hall / Training Hall etc. to RCUN-NER for its programmes to be held in the College.
- d) RCUN-NER will set up a UN reading library at Abhayapuri College while Abhayapuri Colleges shall provide a space exclusively for it and will send its feedback reports to RCUN-NER quarterly.
- e) Abhayapuri College and RCUN-NER shall promote the activities of international Youth Hostel for the welfare of the faculty / Staff / Students of the college and will coordinate and cooperate in the activities of international youth hostel such as membership, UN international days observation tracking, cycling expeditions, students' educational excursions and sports and cultures activites.
- f) RCUN-NER and Abhayapuri College will support and provide help to each other in undertaking any study /research related to sustainable development activities in Assam.
- g) RCUN-NER will nominate a person from Abhayapuri College as a part of delegation for the international conference if required.
- h) Abhayapuri College facilitates an academic enrollment in the college for the benefit of the inmates/ children of the senior officials of RCUN-NER to acquire a better quality education if seat will be available.

3. Implementation of the MOU

The "Co-operating Parties" shall remit within their respective capabilities, mandates and resources, shall make the necessary arrangement to ensure mutually satisfactory implementation of the present MOU.

General Provision:

The MOU shall be effective upon signature by both the parties for a period of 24 months from the date of signature. The MOU may be extended beyond the period upon mutual consent of the parties.

This MOU may be terminated by RCUN-NER or by Abhayapuri College upon written notice to the other party and shall terminate 30 (thirty) days after receipt of such notice from the parties.





Without prejudice to the foregoing steps shall be taken to ensure that the termination of this MOU will not compromise or discriminate against any of the activities or programme undertaking within the MOU framework.

Amendment:

The MoU may be amended at any time by written agreement of both the parties.

Settlement of Disputes:

Any dispute, Controversy or claim arising out of MoU or the breach, termination or invalidity thereof which cannot be settled through direct negotiations, will be amicably settled through reconciliation.
